Since launching in April 2021, the Indigenous Reciprocity Initiative has raised \$292,387 to support community-led, grassroots projects designed and implemented by local communities to address their self-determined needs. Chacruna Institute hosted 14 conferences with accessible online recordings and has reached a cumulative attendance of 11,188 people, provided over 2,340 scholarships for diverse educational programs, and published more than 1,075 articles in English, Spanish, and Portuguese, reaching over 1.7 million readers across 195 countries.
